18-142 **Director’s Report**

- Nine library branches served as Early Voting sites for the General Election from October 22 to November 3: Alafaya, Chickasaw, Edgewater, Hiawassee, South Creek, Southeast, Southwest, Washington Park and West Oaks. There were 108,009 residents who voted at our library locations during Early Voting, representing 61% of the total number of people (177,643) who voted during Early Voting in Orange County. The door count for this 14 day period was 223,000 – an average of 16,000 a day. In addition, the Southwest Branch was a polling site on Election Day and 436 people casted their vote there.
- Youth Services Manager Bethany Stone, has been chosen and has accepted the Chief Branch Officer position.
