#### Resolution to Honor Corbin M. Sarchet, III

Whereas Corbin M. Sarchet, III served as Library Board of Trustees Member and Officer Extraordinaire for the following dates; 1976 - 1978; 1979 - 1987; 1993 - 2002 And whereas Corb:

- **Served** as **Vice President** of the Library Board February 1986 December 1987 **and** April 1995 September 1995. Served as **Interim President** September 1995 -November 1995 **and President** November 1995 October 1998 **and** October 2000 March 2002.
- **Supported** a unique and vital Library to serve the citizens of Orange County bearing the responsibility for the administration of the library and provision of library service.
- Facilitated the creation of the Orange County Library District in 1980.
- Oversaw the expansion and renovation of the Orlando Public Library, the largest public library building in the State of Florida, opened in 1985-86.
- **Encouraged** the Library's growth from a seven Branch System in 1980 to fifteen Branch Libraries today providing library service throughout Orange County.
- Authorized and encouraged the construction of four Branch Libraries.
- **Guided** three directors in the operation of the Library for over 21 years, always remembering and representing the needs of the community.
- **Managed** the Library's budget that grew from 3.5 million in 1980 to over 25 million, when he stepped down from the board.
- **Approved** a new concept for Libraries, the drive-up windows for ease of patron access, and supported special services for citizens such as free home delivery of library materials.
- **Motivated** the Library System to embrace new technologies including computerization of the catalog, online databases, and Internet connections.
- **Insured** the diversity of the Library's collection for adults and children of all ages.
- **Orchestrated** the donation of the "Best of Show" art from the annual Fiesta in the Park art shows for the Library each year.
- **Served** as "citizen watch guard" over the development of the Library's "westerns" collection, the original American art form, according to Corb.

#### The Board Resolves:

To remember and honor Corbin M. Sarchet, III as a long time supporter of the Orange County Library. He served as Trustee Emeritus of the Orange County Library System Board of Trustees, in appreciation of his years of service spanning four decades on behalf of the Library and the Citizens of Orange County. The Board is grateful for his many years of dedicated service and wishes to honor his passing. The Board voted unanimously to approve the resolution.

## **Audio-Visual Equipment Purchase for Library Central: Steve Powell**

Facilities & Operations Department Head Steve Powell, gave an overview regarding the existing audio visual equipment in Library Central. The equipment is 11 years old and at the end of its useful life. Brief discussion ensued regarding the cost and the budgeting for the equipment purchase. Trustee Maladecki, seconded by Trustee Guzmán Beard, moved to authorize staff to contract with ZIO for the purchase and installation of the audio visual equipment in the amount not to exceed \$130,706. Motion carried 5-0.

## **Network Equipment Purchase: Ricardo Viera**

Information Systems Director Ricardo Viera, summarized the government e-rate program, which allows libraries to obtain affordable telecommunications and internet access. Brief discussion ensued regarding the need to purchase new network equipment. Some of the existing equipment is no longer supported by the manufacturer. Brief discussion ensued regarding the equipment and pricing. Vice President Franchina, seconded by Trustee Maladecki moved to authorize Library staff to execute the purchase with Presidio for the Network Equipment in the amount of \$485,141.50. Motion carried 5-0.
